



NEVADA PROGRAM IMPACTS

State Energy Efficient Appliance Rebate Program



The State of Nevada conducted a 2-phase mail-in rebate program to help residents replace older, inefficient appliances with new, ENERGY STAR® qualified models. **Nevada residents received a total of 15,278 rebates, representing total annual energy savings to the state of almost 7 billion Btu.** This is enough energy to light more than 1,000 homes for a year.

MAJOR APPLIANCES

“Nevada’s appliance rebate program was a tremendous success. 15,278 rebates were issued, which equated to \$2,384,800 in rebates made available to Nevadans. Estimated annual savings include more than 1.3 million kWh and 30 million gallons of water, as well as 867 metric tons of carbon dioxide kept from the atmosphere.”

NEVADA AT A GLANCE

- Four products received rebates ranging from \$100 to \$200.
- Refrigerators were the most popular product; the rebated models will reduce Nevada's annual electricity use by nearly 618,000 kWh.
- Nevada received \$2,495,000 from the federal government to implement the program; more than 95 percent of this funding went directly to rebates.
- Retailers and manufactures provided \$130,000 of in-kind support.

KEY DATES

■ **April 17, 2010:**

Program launches with rebates on ENERGY STAR qualified clothes washers, dishwashers, freezers, and refrigerators.

■ **August 31, 2010:**

Wait list closes.

■ **September 1, 2010:**

Program is modified to a buy/reserve format and second round of rebates begins.

■ **December 27, 2010:**

Wait list closes.


■ **March 31, 2011:**

Program closes.



REBATE DISTRIBUTION BY ZIP CODE

The State Energy Efficient Appliance Rebate Program, part of the American Recovery and Reinvestment Act of 2009 (ARRA), provided almost \$300 million in funding to all 56 U.S. states and territories to support consumer rebate programs for efficient appliances. This funding helped consumers replace their existing appliances with ENERGY STAR qualified products. In Nevada alone, the program is projected to save consumers more than \$424,000 annually on their energy and water bills.
