FISCAL IMPACT Renewable Energy Partial Abatement of Sales/Use Taxes August 19, 2026

ORNI 56 LLC LONE MOUNTAIN GEOTHERMAL POWER PROJECT

In accordance with the provisions NRS 701A of the Nevada Revised Statute, ORNI 56 LLC, Lone Mountain Geothermal Power Project has requested a Sales and Use Tax Abatement for their Renewable Energy Project. This project is in Esmerelda County. Upon arrival this project will be granted a partial abatement of Sales and Use Tax for a period of two years, commencing on the date of approval.

The Governor's Office of Energy has provided to the Department of taxation a completed copy of the Renewable Energy Tax Abatement Application for this project. According to Schedule 6 of this application, ORNI 56 LLC, Lone Mountain Geothermal Power Project will purchase a total of \$4,736,195.00 worth of tangible personal property subject to Sales and/or Use Tax during the first fiscal year of the abatement period. At the current Sales and/or Use tax rate for Esmerelda County, the full Sales Tax for these purchases would be \$324,429.36 less any applicable collection allowance.

According to Schedule 7 of this application from ORNI 56 LLC, Lone Mountain Geothermal Power Project will purchase \$1,184,049.00 worth of tangible personal property subject to Sales and/or Use Tax during the second year of the abatement period. Schedule 8 shows no tangible personal property subject to Sales and/or Use Tax will be purchased during the third year.

Based on this information, the Department of Taxation projects the following Sales Tax related impact for the three years of the abatement period.
